

Clinical Teaching Observation Record: guidelines for use

Context and principles

It is a requirement, both of the General Medical Council and of the University of Birmingham, that clinical staff engaged in teaching undergraduate medical students participate in a programme of peer observation of teaching. Peer observation provides tutors with feedback that allows them to improve the quality of their teaching. Benefits also accrue to the observer, who has the opportunity to learn from observing the practice of a teaching colleague.

In peer observation, the emphasis is on development of practice rather than judgement *per se*. Colleagues have the opportunity to discuss teaching approaches and share ideas. This Clinical Teaching Observation Record is primarily intended to provide a structured basis for discussion between the tutor and the observer and should be completed with this aim in mind.

Confidentiality of the peer observation process is paramount, with information from clinical teaching observation records or from accompanying discussions only being released to a third party with the consent of both observer and tutor. However, from time to time, general issues may arise that observer and tutor may wish to bring to the attention of the Head of Academy.

Please note that Heads of Academy are required to keep records of the clinical teaching observations that take place and of which staff have participated.

Definitions

Small group: any group ranging from 1-2 students in a clinic setting, to 4-6 students in a typical bedside teaching session or up to 20 students in a tutorial or seminar session

Large group: More than twenty students, typically in a lecture setting

How to use these forms

To ensure that both tutor and observer benefit from the observation process, please use these forms in the following way:

- 1. Briefing: tutor and observer meet briefly before the session to discuss session context and details, student group(s) involved etc
- 2. **Observation:** observer notes areas of good practice and any areas for development and completes the appropriate form (small /large group).
- 3. **Review:** tutor and observer discuss the session either immediately afterwards or within 2-3 days, using the completed Clinical Teaching Observation Record as a basis. Observer offers the tutor constructive feedback on the session, with suggestions for improvement if appropriate.
- 4. **Report to the Head of Academy:** tutor and observer complete and return **ONLY** the report to the Head of Academy, noting any general issues or comments that they wish to bring to their attention. **NOTE: all other forms remain confidential to observer and tutor.**
